WHEREAS, at a Special City Freeman's Meeting held on May 1, 2000, the electors and qualified citizens of the City of Groton approved the acceptance of a total of 12.439 acres in Mirra Estates Resubdivision;

WHEREAS, the Mayor and Council, at the May 1, 2000 Mayor and Council meeting, finally approved the acceptance of the parcel of open space amounting to 12.439 acres in Mirra Estates Resubdivision; and

WHEREAS, the final approval was published in *The Day*, a newspaper having circulation in the City of Groton on May 4, 2000;
