**95. ORDINANCE AMENDING #74A CONCERNING EXPENDITURES FOR THE  
DEPARTMENT OF UTILITIES 1989 WATER BOND FUND PROGRAM  
(APRIL 4, 1994)**

**BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GROTON:**

**Section 1.** Phase I and Phase II of Section 1 of the Ordinance entitled "An Ordinance Concerning Expenditures for the Department of Utilities 1989 Water Bond Fund Program," approved by the Mayor and Council on September 5, 1989, and amended on January 3, 1994, is hereby amended by deleting said Phase I and Phase II and substituting the following in lieu thereof:
