## BE IT ORDAINED BY THE MAYOR AND COUNCIL:

WHEREAS, the Bozrah Light and Power Company (BL&P) has determined that there is a need to revise the Water Heating Rate of Household Service Rate #1, and to set a new rate for campgrounds located in its service territory; and

WHEREAS, BL&P has determined that these needs can be met by: 1) eliminating the existing Controlled Water Heating Rate and changing the Water Heating Rate to the second block of the existing Household Service Rate #1, and 2) set a new Special Campground Rate to be available to those who make revisions to or build a new campground provided primary metering is installed; and

**WHEREAS**, the Bozrah Utilities Commission, on March 25, 1999, conducted a public hearing on the proposed rate revision and proposed campground rate and has considered all comments presented and correspondence received; and

**WHEREAS**, the Bozrah Utilities Commission has arrived at a revised Household Service Rate #1 and a Special Campground Rate after careful consideration; and

**WHEREAS**, the Bozrah Utilities Commission, at a regular meeting held April 15, 1999, approved the revised Household Service Rate #1 and the Special Campground Rate and recommends its adoption by the City Council;

**WHEREAS**, the City of Groton **initially** approved this Ordinance at a Mayor and Council Meeting held on May 17, 1999 and it was published in **The Day**, a newspaper having circulation in the City of Groton on May 21, 1999 and May 22, 1999;

**THEREFORE BE IT RESOLVED** that the Mayor and Council **finally** approve "An Ordinance Relative to Bozrah Light and Power Company Revised Household Service Rate #1 and Special Campground Rate, effective July 1, 1999; and thereafter until revised, as follows:

## **BOZRAH LIGHT AND POWER COMPANY**

Gilman, Connecticut

### HOUSEHOLD SERVICE

Electric Rate No. 1

Effective in all towns served by the Company.

**AVAILABILITY:** Single phase electric service for dwelling and appurtenances of a single family for its household and farm requirements, subject to the limitations set forth in the company's Rules and Regulations.

#### **MONTHLY RATE:**

Household Service Charge \$8.00

First 500 kWh 9.67 cents per kWh All over 500 kWh & 8.47 cents per kWh

## RATE FOR SEPARATELY METERED WATER HEATING SERVICE:

(closed)

Service Charge \$3.00 per month
All kWh per month 8.47 cents per kWh

**PURCHASED POWER ADJUSTMENT:** If the cost of energy is increased or decreased by our supplier due to a change in prices from the base, an appropriate adjustment shall be made for the sales of energy to each customer as approved by the Bozrah Utility Commission.

**LATE PAYMENT CHARGE:** Accounts with an unpaid balance at the billing date shall be subject to an interest charge at the rate of 1% per month on the unpaid amount.

**RETURN CHECK CHARGE:** Customers will be charged \$15.00 for each check returned by the bank due to insufficient funds.

**TERM OF CONTRACT:** One year and annually thereafter. There shall be an Annual Minimum Charge of \$150.00. This Annual Minimum Charge shall also apply to a customer who requests service be disconnected and reconnected within a twelve month period.

**EFFECTIVE DATE:** With all billings on and after July 1, 1999, and thereafter until revised.

## **BOZRAH LIGHT AND POWER COMPANY**

Gilman, Connecticut

### **CAMPGROUND SERVICE**

Electric Rate No. 080

Effective in all Towns served by the Company.

**AVAILABILITY**: Available only to recreational campgrounds requesting electric service pursuant to P. A. 98-149 whose facilities are primary metered where the customer owns all electric distribution facilities on the customer side of the meter. Limited to lighting, heating and power supplied by the recreational campgrounds to their campsites net of non-residential structures.

The Customer will provide separate metering facilities for non-residential structures on the customer's side of the meter to allow for separate billing under the appropriate rate.

(JUNE 21, 1999)

Subject to the Rules and Regulations of the Company located on the Company's Distribution Lines suitable for supplying the service requested.

### **MONTHLY RATE**:

Service Charge \$9.00

Energy Charge 10.963 cents per kWh

**MINIMUM CHARGE:** \$9.00 per month. However, the Company may require a higher minimum charge where the installation is of large size or is affected by special conditions.

**PRIMARY METERING DISCOUNT**: Where service is metered on the primary side of the transformer bank installed to serve the Customer, the number of kilowatt hours used in computing the charge will be reduced by 2 percent.

**PURCHASED POWER ADJUSTMENT**: If the cost of energy is increased or decreased by our supplier due to a change in prices from the base, an appropriate adjustment shall be made for the sales of energy to each customer as approved by the Bozrah Utility Commission.

**LATE PAYMENT CHARGE**: Accounts with an unpaid balance at the billing date shall be subject to an interest charge at the rate of 1% per month on the unpaid amount.

**RETURNED CHECK CHARGE**: Customer will be charged \$15.00 for each check returned by the bank due to insufficient funds.

**TERM OF CONTRACT**: Not less than one year and annually thereafter unless canceled by six months' written notice. The Company may however, require a longer term of contract, a longer cancellation notice and a Capacity Charge based on a Contract Capacity when the installation is of large size or is affected by special conditions.

Effective: July 1, 1999

(JUNE 21, 1999)

This Ordinance "An Ordinance relative to revised electric rate schedule for water heating rate of household service rate #1 and the setting of a new campground rate for Bozrah Light and Power Company customers" (Ordinance #120) shall become effective July 1, 1999.
