**WHEREAS**, through the process of negotiations the City of Groton (“City”) and the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union, Local 9411-01 (Utilities) (“Union”) have reached a tentative agreement covering the period July 1, 2013 through June 30, 2015; and

**WHEREAS**, Connecticut General Statutes Section 7-474(b) provides that the legislative body of a municipality may approve or reject the Agreement as a whole;

**THEREFORE, BE IT RESOLVED** in accordance with the executed ground rules for negotiations between the City of Groton and the Union and the provisions of Connecticut General Statutes Section 7-474(b), the Mayor and City of Groton hereby accept the Agreement and the Mayor is hereby authorized and directed to execute said Agreement on behalf of the City of Groton.
